Childcare will be provided without cost to you. Please call (518) 439-9252 no later than Friday March 22 to make a reservation for your child or children, noting their ages and any special needs. Please do not bring a child if he or she is showing signs of illness. We ask that no food be consumed in the rooms with the exception of nursing or bottles for infants.

Handicapped accessibility to the building is through all the main doors. All areas of the church, except the pulpit/communion table area at the front of the Sanctuary, are on one level. The pulpit is equipped with a microphone, and speakers are installed around the sanctuary. There is also a hand-held microphone available, and hearing enhancement devices are available upon request.

DIRECTIONS

From Schenectady (West)

Take the Thruway (I90E) to **exit 24**. Continue on **I90E** to **exit 4, Slingerlands Rt. 85**. Take **Rt. 85 through four roundabouts** which puts you on a dual lane 140E. Stay to the right, and go **straight** at the first traffic light thereafter (140E /Kenwood goes left), **on Rt. 52/Cherry Avenue**. Follow Cherry to **Custer Road** (last road on the left before the next light at Delaware Avenue), and **turn left onto Custer**. Take the first **right into parking lot**.

From the North

Take **I87 South to I90 East**. Continue on **I90E to exit 4, Slingerlands Rt. 85**. Take **Rt. 85 through four roundabouts** which puts you on a dual lane 140E. Stay to the right, and go **straight** at the first traffic light thereafter (140E /Kenwood goes left), **on Rt. 52/Cherry Avenue**. Follow Cherry to **Custer Road** (last road on the left before the next light at Delaware Ave), and **turn left onto Custer**. Take the first **right into parking lot**.

From the South

Take Thruway (**I87 North**) **exit 23**. Take ramp on right immediately as you exit the toll booths to **9W** toward Delmar. Turn **right onto 9W** and proceed through 3 lights. Bear **right onto Rt.32** toward Delmar. Follow Rt. 32 (dual lane highway) to light at Elm Avenue. Turn **right on Elm**, and proceed to the first traffic light at Delaware Avenue. Turn **right onto Delaware** and an immediate **left into parking lot**, or proceed straight through and take the first right onto Custer and immediate right into parking lot.

From the East

Take **I90 West to Rt.787 South**. Follow 787 to the end at Southern Blvd. Turn **right onto Southern Blvd/9W**, pass through 2 lights, crossing over the Thruway exit 23 and proceed as above, from the South. **Or**, if you prefer the scenic drive, turn left at the light onto Southern Blvd, which becomes McCarty, and follow to the light at the intersection with Delaware Avenue. Turn left onto Delaware Avenue, and follow several miles, past the village 'Four Corners'. The church will be on the right just before the light at Elm/Cherry Avenues and Delaware.
