Re: STATISTICAL REPORTS FOR 2022

Dear Clerk of Session:

Thank you for serving as Clerk of Session for your congregation! You play an important role in the ministry of your church and it's my privilege to serve as a resource to you and your session as the presbytery's Stated Clerk.

It is once again the time of year where we ask you to enter your congregation's statistical data into the system set up for us by the Office of the General Assembly (OGA) of the Presbyterian Church (USA). Gathering and entering this ensures that we have the latest denomination-wide statistics but it also determines your church's Annual Basic Witness Support [Per Capita] paid to the presbytery. Changes made in your membership in 2022 will be reflected in your 2024 Basic Witness Support assessment.

If you are a seasoned Clerk, you can ignore the rest of this message and move right to the entering of your data at the following link: <u>http://oga.pcusa.org/stats</u>. You will need your church's login information, which I can retrieve for you swiftly upon request.

If you are not familiar or need a refresher on the process, below are some helpful points to guide you through the process:

- → Allow time to consult with others such as your pastor(s), moderator, treasurer, or other church leaders if their assistance will be required for you to complete the various forms and meet the deadlines. If you were not given the login information for your congregation, reach out to the Stated Clerk and he will retrieve it for you.
- → Your absolute deadline for submitting this report online is 5 p.m. on Thursday, February 16, 2023. However, we recommend that you enter your data as soon as possible as the statistics portal can be slow during the last week of reporting.
- → Please be sure to download and print out a copy of your statistical report immediately after it has been completed and include that report with the minutes of your next session meeting.

In addition to statistics, the presbytery also gathers information from each of our churches. This year, we are requesting three things:

 An electronic copy of your 2022 ANNUAL REPORT for your congregation. Please send to <u>dbennett@albanypresbytery.org</u>. If you are unable to scan your report or send via email, please send a hard copy to me at the address below my signature.

- 2. A NECROLOGY REPORT listing all Ruling Elders and Deacons who passed away in 2022. Please use this <u>Google Form Link</u> to submit your congregation's necrology report. Or, feel free to email or mail a paper copy of your list to me using the address below my signature.
- 3. A GENERAL INFORMATION Form so that we can update the Presbytery website with correct data for your church. This information is needed for both internal presbytery use and for people who use the website to locate a PC (USA) Church in our region. <u>Click HERE to access the form</u>.

Please do not hesitate to contact me if you need assistance with your reporting or have any other concerns as you serve as Clerk of Session in 2023.
