

## APPROVED PREACHING LIST AS OF July 24, 2017

### HONORARIA AND EXPENSES

Please note: The Presbytery has acted to establish \$140 plus mileage reimbursement at the current IRS rate (0.535 cents per mile as of January 1, 2017) as the minimum honorarium for temporary supply preachers and \$70 plus mileage and expense reimbursement as the minimum honorarium for visiting moderators. It is expected that payment will be made at the time of service. Mileage can be determined at websites such as Mapquest.com.

According to the Church and Clergy Tax Guide section on Church Reporting Requirements, churches are subject to one or more Federal reporting requirements. One such requirement follows: "providing each self-employed person (receiving compensation of \$600 or more) with an annual statement of non-employee compensation (Form 1099-MISC)."

# **PRESBYTERY OF UTICA**

## **HONORARIA AND EXPENSES**

The standard minimum honorarium for both clergy and Authorized Lay Preachers (including Commissioned Lay Pastors currently without a commission) in the Presbytery of Utica is \$150.00. Churches are advised to consider higher honoraria as appropriate. If worship includes yoked or multiple services an additional \$25.00 is standard.

A minimum honorarium of \$25.00 plus mileage at the standard IRS business rate for 2017 of 0.535 cents per mile is required to compensate those assigned to moderate meetings by the Committee on Ministry.

Mileage reimbursement for the purpose of supply preaching is the current, January 2017 IRS rate of 0.535 cents per mile.

Reimbursement of additional expenses may be negotiated between the church and individual.

### **Honoraria and expenses are to be remunerated on the day of service.**
